RE: Waiver Request for Expenditure Deadline/Time Extension of Shelby County, Tennessee NDR Grant

Dear Grants Director:

Shelby County, Tennessee is hereby requesting that the U.S. Department of Housing and Urban Development authorize a waiver extending the expenditure deadlines for funds associated with the newly awarded National Disaster Resilience (NDR) grant.

As outlined in the attached NDR Project Schedule, each of the major activities funded through the NDR grant are complex infrastructure projects which will impact wetlands and floodways within Shelby County and as such will require pre-development and development components which will necessitate various time extensions in order to complete each activity under the NDR grant.

Based on past experience with similar activities in wetlands and floodways, complex issues such as engineering, the acquisition of environmental permits, land acquisition and buyouts, citizen input on each activity, various governmental approvals, and final designs of each activity are anticipated to take approximately 2 years before actual construction begins in each targeted area.

Presently the County is completing the construction of the Fite Road project which required multiple permits and agreement with the Railroad. The Grant funds for the project were awarded in September 2011 with construction starting in June 2014. This time line is very similar to the 2 year and 9 month scheduled from the acceptance of the NDR Grant funds start of construction for the Big Creek project.

Having experience in such projects, Shelby County's Division of Public Works has carefully analyzed each activity based on experience with similar project timelines and has developed the attached schedule outlining anticipated milestones for each activity component. This project schedule outlines how activities will progress during each specific expenditure deadline/time extension per this request. The schedule also serves to insure that each activity proceeds in a timely manner in order to meet the requested extensions. These extensions for the use and expenditure of grant funds are fully outlined in the NDR Project Schedule attached to this letter.

Shelby County is specifically requesting waivers for the South Cypress Creek, Wolf River Greenway, Big Creek Floodway, and Administration activities under NDR. Shelby County is not requesting an expenditure deadline or time extension for the Regional Resilience Plan activity. The timelines for these requested extensions for the use and expenditure of grant funds are fully outlined in the attached NDR Project Schedule; but in brief are as follows:

1. South Cypress Creek Activity

2. Wolf River Greenway Activity

3. Big Creek Floodway Activity

4. Administration Activity

Waiver Request: Completion Date September 15, 2020

Waiver Request: Completion Date May 15, 2021

Waiver Request: Completion Date August 1, 2021

By granting these waivers, HUD will enable Shelby County to insure full citizen participation in all stages of progress for each activity; assist Shelby County in establishing a realistic and workable time line for the expenditure of funds and project completion; and enable Shelby County to insure that all activities are of maximum benefit to the residents of the targeted areas impacted by the use of NDR grant funds.

As Shelby County Mayor, I would appreciate your consideration and approval of this waiver request and look forward to working with HUD staff in the coming years as we implement the NDR here in Shelby County for the benefit of our residents and community.
